

Why FMCS?

“Grants are available to labor-management committees that emphasize improved labor-management relationships, increased job security, enhanced economic development and employee involvement in decision-making processes.”

What Is The FMCS Grants Program?

The FMCS Grants Program provides funding to support the establishment and operation of joint labor-management committees at the company level, within a particular geographic area, within a particular industry, or for public-sector employees. Federal agencies are not eligible for a grant. Grants are provided to labor-management committees that emphasize:

- Improved labor-management relationships
- Increased job security
- Enhanced economic development
- Employee involvement in decision-making processes

Is Your Organization Eligible For A Grant?

Labor-management committees funded under this program are not limited to any particular activity. However, labor-management committees must represent an employer and a workforce covered by a formal collective bargaining agreement to qualify. In order to be eligible for a grant, the labor-management committee should demonstrate how it will use grant funding to fulfill one or more of the following objectives:

- To improve communication and working relationships between labor and management.
- To provide employers and employees with tools to achieve organizational effectiveness through innovative joint approaches.
- To assist employees and employers in solving problems of mutual concern.
- To explore ways to enhance economic development including addressing real or potential problems.
- To enhance employees' involvement in decisions affecting their jobs.

How Do I Apply?

Grant applications are available throughout the year and are evaluated and awarded quarterly until all appropriated monies are expended. The instructions for preparing grant applications are revised annually and are published in the FMCS Application Solicitation/Program Guidelines. Who Selects Grantees?

The director of the Grants Program selects the grantees based upon recommendations from a Grant Review Board. Generally, the Board is composed of public and private sector members of the labor-management community and FMCS mediators. The Board scores and ranks each application and forwards its recommendations to the director of the Grants Program for final scoring and selection. The final selection is made by the director of FMCS.
